- 4.) The C.O.D. discussed concerns raised by the Select Board that the C.O.D. not reach out to the Mass. D.O.T. without going through the Town Administrator's office first. The Commission composed an E-Mail in response to their concerns, assuring them that all past contact with the D.O.T. has been made with the knowledge of the Town Administrator and that it would continue to be this way.
