# **APPROVAL OF MINUTES:**

#### **POLICE CHIEF RETIREMENT:**

A notice of retirement was received from Police Chief James McGarry. <u>Selectman Hannum moved to accept the notice of retirement from Police Chief James McGarry effective July 31, 2012, seconded by Selectmen Wood. The motion carried unanimously.</u>

# RATIFICATION OF FINANCE COMMITTEE APPOINTMENTS:

Moderator Bruce Person submitted a letter to reappoint John James and Colin Smith to the Finance Committee. <u>Selectman Wood moved to ratify the appointments of John James and Colin Smith for a three year term to the Finance Committee, seconded by Selectman Hannum. # **AGRICULTURAL RESTRICTION-WEST ROAD:**

#### **CLOTHING RECYCLING BOX:**
