Administrator LaBombard stated that the Goodwill will be requesting permission to park the Goodwill truck in the Village Green one weekend day per month to receive donations. Discussion ensued. It was the consensus of the Board to allow the Goodwill truck to be parked in the Town Hall parking lot one weekend day per month to receive donations.
