### BOARD OF SELECTMEN MINUTES December 12th, 2016 7:00 pm TOWN OFFICES

The Board of Selectmen convened its meeting on Monday, December 12th, 2016 at the Town Offices, Meeting Rooms A & B, Chairman Kendra J. Dumont presiding, with Selectmen Robert E. Prescott, Enrico C. Cappucci, and Town Administrator Patrice Garvin in attendance.

#### CALL TO ORDER

Chair Dumont called to Order the Board of Selectmen's Meeting at 7:00 pm.

#### TOWN ADMINISTRATOR REPORT

1. Last week the School Committee passed a motion to join in on a fixed 25% net metering program, pending legal review. The ASRSD has already started the budget for next year, so they won't be including the savings until they have better numbers a year from now. This change will result in real savings for the schools, thus the Towns.
2. I wanted to update the Board on the Ambulance funding that passed at the November 19th Special Town Meeting. According to the Fire Chief all shifts for the month of December, excluding Christmas, have been filled. The increase from \$50 to \$100 hard calls has seemed to result in more participation, thus enabling the ambulance to get out the door sooner.
3. The financial policies group had their last formal meeting. The document is on the Finance Committee's agenda on December 13th. While discussing reserves and undesignated fund balance it occurred to the group that in three short years the Town's position has done a 180. As I stated at Town Meeting the reserves are healthy and growing and the undesignated fund balance (non-appropriated funds) is strong. I equate this to all the hard work the administration has done to improve the financial position of the Town of Shirley. Moving forward into Fiscal Year 18 we will be in a better position to address any shortfalls.

4. The moving of some departments is progressing. The Recreation Department was successfully moved to the second floor. As the Board knows this is a project that has been in the works for a long time. Now that the Town has hired a Facilities Coordinator the move has finally begun. The next move will be to place the Inspections Department in a more visual and accessible office, which is on the first floor. This move will accommodate the public much better.



My name is Alfreda Cromwell. I was an officer with the Shirley Police Department and was recently wrongfully terminated by the board of selectman on November 9, 2016.

On November 9, 2016, the board of selectman held an executive session to determine whether there was just cause to terminate me. I requested that this meeting be public (in which my request was granted). Many members of the public attended. During this meeting, a secret note was passed between the town administrator Patrice Garvin, Selectman Robert Prescott and Chairwoman Kendra Dumont. They did not disclose this information with myself, the public or Selectman Rico Cappucci. I believe that this act was an intentional violation of the open meeting law because essentially, communications through passing the note withheld information from me and the public. In this executive session they voted 2-1 to terminate me for untruthfulness. Ultimately, the public nor I did not have the opportunity to hear all of what was communicated in this executive session. This occurred in front of the public and captured on video. See video link [www.youtube.com/watch?v=HCH06nWFLYE](http://www.youtube.com/watch?v=HCH06nWFLYE).

In summary, I was accused of giving false testimony in a previous executive session hearing on November 1, 2016. This was not true and I provided a witness who testified in the executive session. This witness provided testimony on my behalf and corroborated my testimony. During the session, the board of selectman did not offer a witness to testify, but offered a written statement by her.

In addition, I requested that the meeting on November 1, 2016 be conducted in public. During this meeting, I gave a brief statement. After reading the statement aloud, the members of the public gave me a standing ovation, cheered and applauded me. Subsequently, Chairwoman Dumont instructed that all members of the public be removed in which they were removed by state police troopers and other officers. I believed that this was a blatant violation of the open meeting law because I specifically exercised my right to have this meeting open to the public. Although a general instruction to the public was given at the beginning of the meeting about disruptive behavior, the members of the public were not given the warning to be silent before being removed.

What action do you want the public body to take in response to your complaint?
