The Board of Selectmen re-convened its meeting in open session on Monday, May 1st 2017 at the Town Offices, Meeting Rooms A & B. Members present were Chair Enrico Cappucci, Holly Haase, James Wilson and Town Administrator Patrice Garvin.

TOWN ADMINISTRATOR REPORT

Town Administrator Patrice Garvin gave her weekly report:

A Meeting with the Moderator and Town Counsel is set for Friday, 5/5/17. At this meeting we will be discussing Town Meeting and the Articles that will be brought to the floor of Town Meeting. This is a meeting we have prior to all Town Meetings so everyone can have a sense of what to expect regarding warrant articles.

The Finance Committee is meeting on Monday, May 1st to review the final warrant and budget. The Finance Committee is making their recommendations on the town meeting warrant articles. Their budget and budget message will be finalized and the warrant will be mailed on Monday, May 8th to residents.

I met with the Ayer's Town Administrator, Ayer-Shirley School Superintendent and Kelly Brown from the Massachusetts Department of Energy to discuss adding the school district to each Town, designating the district as a green community. Adding the district to the Town's would allow the schools to be eligible for green energy grants through the state. This will be an item on one of your upcoming agendas for approval. The school is going to conduct a building assessment to see if there are any projects for the schools they would like to advance forward for grant opportunities.
