Maryann Bessette brought the film, "Last Will and Embezzlement" for viewing by the Commission. The film features two cases of seniors who have been scammed. The COA purposes showing the film at the Olde Mystick Village Art Cinemas and having a law enforcement official and perhaps a lawyer there for a question and answer session afterwards. This presentation would be part of the proposed senior media campaign that the COA is planning with S.A.L.T. and Senior Resources.

S.A.L.T. meets every quarter to decide on what senior programs the town will offer. Lisa Ryan proposed joint meetings of the S.A.L.T. Commission and the Commission on Aging for the purpose of planning for the senior media campaign. She will attend the next S.A.L.T. meeting and will inquire about joint meetings or having planning meetings for the senior media campaign.

Betty Henry presented a report on the affordable housing project in Pawcatuck. Betty is a member of the Affordable Housing Committee, and she reported that the affordable housing project planned in Pawcatuck is proposed to have 45 units. The affordable housing formula calls for 20% of the units to be provided for families whose income is 80% of the area median income; 15% of the units for families whose income is 60% of the area median income with the balance of the units at 100% of the market rent price. Betty reported that there will be a Planning and Zoning Meeting on June 5, 2012.

Also, for those who may be interested in joining, the Affordable Housing Committee meets on the first Tuesday of the month at 4:00 p.m.
