The educational program is entitled "Living With Alzheimers. It is a three part program and each part has three modules. There are components for the caregiver and components for the patient. The Commission would like to explore the possibility of having the Alzheimer's Association do two presentations (one for service providers and one for caregivers of those with Alzheimer's disease). There will be further discussion on venues and dates.

Lisa Ryan presented information that she gathered when she attended a meeting in Hartford on Creating Communities for a Lifetime. The program is aimed at creating a Liveable Community for All Ages so that people can age in place. Lisa mentioned OSCA (Our Shoreline Community Association) in Noank. OSCA encompasses Groton Long Point and now Stonington. Lisa would like to invite them to do a presentation for the COA.
