# STONINGTON BOARD OF EDUCATION REGULAR MEETING NOVEMBER 12, 2009

Bill King explained and reviewed the water main break on West Vine Street and how it affected West Vine Street School. He explained the evacuation process and the administrative review that followed the crisis response.

Dr. Smotas informed the Board that the use of Alert Now has been exemplary and the number of complaints received were minimal.

Dr. Stephen Murphy, Stonington High School Principal, addressed the Board on the advantages of Alert Now and how they have been able to send messages to select groups and eliminate sending messages to families to whom they would not pertain.

C. Capital Improvement Plan

Bill King presented the proposed five-year Capital Improvement Plan. He explained the number of requests that have come in and which of those will be requested for the 2010-11 Budget. Bill answered the Board's questions and concerns. This will be on next month's agenda for Board action.

A. Full Day Kindergarten Presentation

Leanne Masterjoseph opened discussion concerning Full Day Kindergarten and introduced Virginia Brown, West Vine Street School Principal and Tricia DeLapp, West Vine Street Teacher.

Virginia Brown presented a slideshow and explained each of the following:

Gail MacDonald informed the Board about the LEARN Board wanting a representative from the Board of Education. She also discussed having a Board of Education representative on the Stonington Prevention Council.

Sam Agnello informed the Board of anr unexpected visitor to the Athletic Committee meeting, Mark Wallace and his presentation and request for a wrestling team at the middle school level. Mr. Agnello further explained that this is a program that is currently run in Westerly, Rhode Island, but not something Stonington could currently do.

Dr. Smotas informed the Board about the Friends of Stonington Crew (FSC) and their offer to turn over their equipment to the Board of Education. He also informed the Board of a proposal possibly coming to the Board next month from FSC.

F. Education Legislation Summary

Dr. Smotas explained the attachment for the Board's information and the relevance of the underlined sentences.

G. CAPT 2009 Recognition Letters Dr. Smotas explained this attachment and that there were eleven recipients in from Stonington High School. H. Non Public School Report

Dr. Smotas presented the Non Public School Report to the Board and explained the number of Stonington students that are attending Saint Michaels and Pint Point Schools.

I. Legal Opinion Regarding Bus Contract

Dr. Smotas highlighted the opinion by the Town attorney. He will prepare a letter to be presented to the Town Finance Board for deliberation at its meeting of December 2, 2009 and he will ask for support for Board of Education action.

J. Strategic School Profiles

Dr. Smotas explained how each schools information will not see significant changes over last year. He discussed that class sizes at the High School are up and offered his recommendation that when monies free up to reestablish the reducing high school class size. He also discussed the discrepancies between Pawcatuck Middle School and Mystic Middle Schools hours of instruction, at which time Leanne Masterjoseph was able to state that the discrepancy has been identified and rectified so that all hours align.

K. Suspension and Expulsion Policies

Dr. Smotas explained this had already been talked about during the Athletic Committee Report.

Bill King addressed the Board on what the processes would be in order to secure a new company to handle all copier needs.
