

The referendum will be held pursuant to the provisions of Section 7-7 of the General Statutes of Connecticut.

Persons, not electors of the Town of Stonington, being citizens of the United States, age 18 years or older, jointly or severally liable to the Town of Stonington for taxes on an assessment of not less than \$1000 on the last completed grand list, desiring to vote pursuant to the provision of Section 7-6 of the General Statutes of Connecticut, shall vote in the First Voting District at the Stonington Fire Station, 100 Main St., Stonington. Absentee ballots will be available from the Town Clerk's office during normal business hours beginning on Tuesday, May 1, 2012.


The Board of Finance's recommended budget for Fiscal Year 2012/2013 carries a 16.05 mil rate and will be placed on the voting machine under the following heading:


Those voting in favor of said item will vote "YES", and those voting against said item will vote "NO".
