MEETING MINUTES

1) Call to Order

Chairman McCabe called the meeting to order at 7:00 PM.

2) Remarks of the Visitors

Melanie Degler, Stonington Resident Ms Degler attended the 9/14 Police Commissioners meeting to discuss her concerns regarding the traffic issues at the intersection of Wilcox Road, Route One and Old Stonington Road. She stated there has been increased traffic due to the new Lamb's Way development, and that the current signage stating "no outlet" and "no left turn" are not being obeyed by motorists. Ms Degler also gave various accounts of serious accidents that have occurred at the intersection due to motorists illegally exiting Old Stonington Road going east onto Route One. There was a discussion and agreement that this is an area of concern. Options were discussed to increase signage or to make the Old Stonington Road one way. Chairman McCabe stated that no matter what motions were made the State of CT must be involved, as Route One is a state road. Chairman McCabe then suggested proposing the idea of making Old Stonington Road one way heading westbound to the State Traffic Commission. Captain Desmond stated a letter must also be written by the Commission to local residents and businesses addressing the situation and proposed solution. Clerk O'Boyle made a motion to write a letter to residents and businesses, the motion was seconded by Commissioner Holstein and it was voted. Discussion to follow at next meeting.

- All special events went well. One area of concern was the traffic congestion that occurred at the Sergio Franchi Estate during the annual concert. More officers may be needed, as well as an adjusted start time to allow cars in earlier.
