MEETING MINUTES

1) Call to Order / Pledge of Allegiance

Chairwoman Tibus called the meeting to order at 5:00 PM.

2) Remarks of Visitors

Sloan Danenhower

Interested in bringing "duck" boats to Mystic. Presented information packets to Commission, Chief and Captain. Commission will review; item will be added to next month's agenda.

Gleanna Doyle, Mystic, CT

Spoke to Commission regarding her concern for pets left in parked cars, requested installation of signs on Town property warning of danger this poses to pets.

Presented Commission with information, flyer she created, and the sign she would like installed. Ms. Doyle will approach private property owners in areas of concern.

Chief Stewart stated he spoke to Ms. Doyle previously and believes parking lots tend to have more of these issues as opposed to streets, and will pursue the matter.

Fred Brook, Angel Ride

In attendance to request approval for, and answer any questions regarding, the Angel Ride, a two day, 135 mile bike ride across Connecticut benefitting children with cancer. Mr. Brook also submitted a safety plan to the Commission and Chief Stewart, noting that the ride may need to take an alternate route depending on completion of bridge repairs at the entrance to River Road in Mystic, CT (Groton side).

Chief Stewart and Captain Desmond stated the safety plan submitted is very thorough, and recommend approving the Ride.

A motion was made by Commissioner Pucci to approve the Angel Ride, provided all necessary paperwork and insurance is in place. Motion seconded by Vice-Chair Coan and approved.

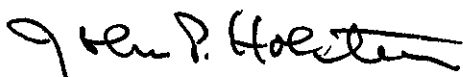
