MEETING MINUTES

Present: Chairwoman Susette Tibus & Vice-Chair Dr. Stephen Coan Commissioners Scott Bates, John Holstein and Frank Pucci Chief Darren Stewart and Captain Jerry Desmond

1) Call to Order / Pledge of Allegiance

Chairwoman Tibus called the meeting to order at 5:00 PM.

2) Remarks of Visitors

Speeding on Mason's Island

Jim Stanton, 46 Masons Island Road, Mystic

Concerned with traffic on Mason's Island Road, and would like Commission to review area. Mr. Stanton stated that speeding is not specific to any particular set of individuals, nor is it seasonal; it is an ongoing problem.

Chief Stewart stated he has spoken with Mr. Stanton and recognizes his concerns. Chief Stewart recommended increased enforcement in the area as the best option to deter speeders.

Asa Pollard, 11 Rogers Drive, Mystic

Mr. Pollard stated he shares Mr. Stanton's concerns with speeding on Mason's Island, as well as dangers faced by pedestrians.

Captain Desmond stated he will put speed trailers and officers' onsite to observe and enforce.

Commissioner Bates relayed a similar problem that occurred in Stonington Borough and supported the enforcement option suggested by Chief Stewart and Captain Desmond.

Director of Public Works Joe Bragaw stated he also believes enforcement is the best available option to deter speeders.

Chief Stewart will report back to Commission at next meeting.
