MEETING MINUTES

1) Call to Order / Pledge of Allegiance

Chair Tibus called the meeting to order at 4:00 PM, and welcomed Commissioner Mel Olsson.

2) Remarks of Visitors

Joyce McElhaney, Connecticut Community Credit Union Concerned for employees, customers and pedestrians that cross in the crosswalk in front of the credit union. Stated that drivers pass by well above the speed limit, and there have been several instances in which pedestrians crossing

were almost hit. Ms. McElhaney questioned whether anything can be done to improve safety, and suggested signage at the site of the crosswalk.

Chief Stewart clarified that private agencies cannot request signage for roads, and unfortunately there is not personnel available to manage daily placement of a sign.

Chair Tibus suggested Ms. McElhaney send a letter to the Chief requesting signage that can be located at the crosswalk, so that he can then forward on.

Ms. McElhaney stated the credit union will commit to daily placement, at opening and closing, Monday through Friday, for a trial period of 90 days.

Richard Froh, Vice President, Mystic Community Bikes

Organizing Mystic bike tour, and would like to approach various merchants & request they provide an incentive, utilizing tickets that will be shown at businesses for a discount. Would like to use Mystic YMCA as an initial meeting place. Registration will start early in the morning, approximately 6:30am. Requesting approval.

Chief Stewart noted that the use of Mystic YMCA involves crossing US Route One, therefore a Highway Use Permit will be required, as well as a permit from the local traffic authority. A safety plan will also be required. Chief Stewart stated that too much information is missing at this time; Commission agreed.

Chair Tibus suggested Mr. Froh work out safety issues with his group, and come back to the Commission once he is able to provide more information; Chief Stewart will provide a list of necessary requirements.
