MEETING MINUTES

Chair Tibus deferred to Chief Stewart

Chief Stewart stated the Mystic Irish Parade is great community event, the Committee is very cooperative, and conversations have always gone well, however the goal this year is to maintain a family friendly environment and eliminate alcohol related incidents.

Chief Stewart stressed that he has never had an issue with the Parade Committee; advertisements should be free of alcohol, and merchants should receive a letter requesting cooperation. The Chief suggested a personal representative visit each establishment, and that there should be additional Parade Marshall's, as well as police officers, at the event this year. In addition, the Chief stated the joint press release/press conference should relay the message of a family friendly, alcohol free event.

Lt. Beebe suggested that plastic cups should not be allowed, and that this should get mentioned to establishments serving alcohol. He also reiterated that the Committee has been a pleasure to work with.
