The Board of Finance held a special meeting on this date at the Police Department meeting room. Members present were Glenn Frishman, Chairman; Andrew Rines, Secretary; John O'Brien; Bryan Bentz, Dudley Wheeler and Sandy Grimes. Also present Maryanna Stevens, Director of Finance; First Selectman Ed Haberek, Town and Board of Education staff and residents.

Chairman Frishman called the meeting to order at 7:00 p.m.

Previous Minutes

Chairman Frishman called for a motion to approve the minutes of the March 7, 2012 meeting. Mr. Wheeler approved the minutes as presented, Mr. Grimes seconded and voting was unanimous.

Additional Appropriations/Bid Waivers

Wastewater Treatment Facility—Chairman Jim Sisk spoke to the request from the Water Pollution control authority for a bid waiver. The WPCA has chosen CDM Smith as General Contractor. Mr. Sisk explained that this would save considerable time and money. CDM Smith has guaranteed a maximum price of \$17.2 million. CDM Smith will prepare, seek and obtain all bids. Members discussed construction management costs as well as possible environmental issues. Chairman Frishman called for a motion to approve the bid waiver for CDM Smith as General contractor to obtain all bids for the construction of the wastewater treatment facility improvements. Mr. Grimes approved the bid waiver, which was seconded by Mr. Rines and unanimously approved.

Recreation Commission – Members received a bid waiver request for Dalton Track of Cheshire, CT as well as an approval from the Board of Selectmen for a \$19,500 Additional Appropriation to repair the tennis courts in the Spellman Park complex. Recreation Commission Chairman Michael Crowley stated the repairs are guaranteed for three years possibly five. The commission has \$9000 on hand toward these repairs. Chairman Frishman called for a motion to approve the bid waiver to secure Dalton Track of Cheshire, CT and an additional appropriation of \$19,500 to repair the tennis courts located in the Spellman Park Complex. Mr. Grimes approved the bid waiver and additional appropriation, which was seconded by Mr. O'Brien and unanimously approved.

Budget deliberations

At this time, Chairman Frishman stated that the current 2011-2012 mil rate is 15.63. The proposed 2012-2013 budget stands at 16.46, a .83 mil rate increase. Mr. Frishman stated that while the average budget increase over the past few years was only .66%, the average tax increase was 1.63% due to declining revenue from the state, building permits, conveyance taxes and interest income. Members asked Finance Director Maryanna Stevens for the available fund balance. She stated there is \$2.5 million available to offset the budget, yet she advised them to be prudent. Mr. Frishman asked the members for their target budget. Messrs. Rines and O'Brien felt a .50 mil rate increase was appropriate. Mr. O'Brien added that he would like to leave the Board of Education budget to the voters as suggested at the previous budget hearing. Mr. Bentz agreed.
