<u>Application:</u> IW #13-13 Town of Stonington – Seeking a permit for sports field renovations and drainage improvements to upgrade and repair existing playing fields within the upland review area. Property located at 176 So. Broad St., Pawcatuck. Assessor's Map 25 Block 1 Lot 19 Zone RR-80

Larry Sullivan, Town Engineer was present for the application. He explained areas of grading and stated that the application was for more items than will most likely be approved as funding was depleting.

<u>Application:</u> IW #13-14 Board of Education (TOS) – Seeking a permit for the removal of 4 ft. stone dust track and installation of a 4 ft. wide bituminous concrete track in the same location within the upland review area.
