# Mystic Harbor Management Commission June 3, 2010 Approved

The Mystic Harbor Management Commission held a regular meeting on Thursday, June 3, 2010 at 7:30 p.m. at the Fourth District Voting Hall. #### Call to Order

# Unfinished Business: Dredging of Channel

#### "Slow-No-Wake Zone"

Remarks were made concerning the proposed amendment to DEP Regulation Section 15-121-B150 'To make the entire Mystic River a slow-No-Wake zone' Chairman Carreau stated that The Mystic Harbor commission was not asked to participate in the discussion leading to this proposed change. Discussion reveled that the law will be broken by the large passenger vessels because of their speed length ratio which do not leave much wake. Rowing shells also achieve higher speeds. The real problem is damaging waves which have been difficult to enforce. Coordination between the Harbor Master and the Stonington police has been effective using CGS Section 15-140 which addresses reckless operation enforcement. (See page 35 Mystic Harbor Management Plan) Disappointment was expressed for the lack of concern for local marinas and their engine repair business. All agreed that something had to be done about excessive speed and damaging wakes. Harbor Master Watts believes it is a step in the right direction. Commission members will attend the public hearing on June 29, 2010.
