

## Special Meeting

The 1359th meeting of the Stonington Planning and Zoning Commission was held on August 21, 2007, at Pine Point School at 7:00 p.m. Present for the meeting were: Commission members Charles Sneddon, Julianne McCabe, Paul Altman, Lynn Young; and Alternates Robert Marseglia, and Paul Holland. Also in attendance was Interim Director of Planning Keith Brynes.

Chairman Sneddon called the meeting to order at 7:00 p.m.
