# **Special Meeting**

The 1426<sup>th</sup> meeting of the Town of Stonington's Planning and Zoning Commission was held on Tuesday, August 17, 2010 at Pine Point School, 89 Barnes Road, Stonington. The meeting was called to order by Chairman John Swenarton at 7:00 p.m. Commissioners Bob Mercer and Ben Tamsky, Alternates Rob Marseglia and Gardner Young, Town Planner Keith Brynes, and Director of Planning Bill Haase were present. Commissioner Paul Holland arrived at 7:10 p.m. Commissioner Lynda Trebisacci was absent.

Seated for this meeting were Mr. Young, Mr. Marseglia, Mr. Mercer, Mr. Swenarton and Mr. Tamsky.

#### Minutes

Mr. Mercer made a motion to approve the minutes of August 3, 2010 as amended. Mr. Tamsky seconded. The minutes were unanimously approved, 5-0.

Mr. Tamsky made a motion to approve the request. Mr. Mercer seconded. The motion was unanimously approved, 5-0.

**PZ0603SD Arlene Steinlauf & Stephen Yardan, Trustees** – Request for 90-day extension to file final subdivision mylars. Property located off Jeremy Hill Road, Stonington. Assessor's Map 90 Block 1 Lot 1. Zone RR-80.

Assessor's Map 162 Block 2 Lots 9A-9P, Map 162 Block 2 Lot 10, & Map 162 Block 2 Lot 11. Zones RH-10 & RA-20.

Attorney Ted Ladwig presented the Zoning Map Amendment application. The zone change would increase the F.A.R., allowing the property owners to increase the size of their homes.

Mr. Brynes reviewed the comments from the DEP.

Mr. Holland made the motion to find that the application is consistent with the POCD and the Comprehensive Plan. Mr. Marseglia seconded. The motion was unanimously approved, 5-0.

Mr. Holland made a motion to approve the application. Mr. Mercer seconded. The motion was unanimously approved, 5-0. The effective date for the Zone Change is September 6, 2010.

Mr. Holland made a motion to adjourn. Mr. Tamsky seconded. The motion was unanimously approved, 5-0. The meeting was adjourned at 8:35 p.m.
