

ANNUAL TOWN BUDGET MEETING
April 28, 2010

First Selectman Edward Haberek, Jr. called the Annual Town Budget Meeting of the Town of Stonington to order at 7:00 p.m. on April 28, 2010 at the Stonington High School auditorium. In attendance were First Selectman Edward Haberek, Jr., Selectmen George Crouse and Glee McAnanly.

Mr. George Sylvestre nominated Mr. James O'Boyle as Moderator being properly seconded and being no objections Mr. O'Boyle was unanimously elected Moderator of the meeting, and Town Clerk, Cynthia Ladwig served as clerk. Approximately 20 people attended.

There being no objection, the Moderator dispensed with reading the Call recorded immediately preceding these pages and asked for a resolution on the first item on the Call.

First Selectman Haberek moved and read the following resolution:

BE IT RESOLVED BY THE LEGAL VOTERS OF THE TOWN OF STONINGTON IN LAWFUL TOWN MEETING DULY ASSEMBLED, THAT:

"THE FOLLOWING, BEING SUFFICIENT SUM OR SUMS OF MONEY TO CARRY ON THE VARIOUS DIVISIONS OF TOWN GOVERNMENT, BE AND HEREBY ARE APPROPRIATED FOR THE FOLLOWING PURPOSES, FOR THE FISCAL YEAR BEGINNING JULY 1, 2010, ALL OF WHICH HAVE BEEN APPROVED AND RECOMMENDED BY THE BOARD OF FINANCE TO THE EXTENT OF THE AMOUNT APPEARING OPPOSITE EACH:

The Board also voted to send the first item on the call of the Annual Town Budget Meeting called for April 28, 2010 to referendum. The Board set Thursday, May 6, 2010 for the date of the Referendum to be held in the following voting places between the hours of 6 a.m. and 8 p.m.

The wording for the question will be as follows:

"SHALL THE TOWN OF STONINGTON MAKE APPROPRIATIONS IN THE TOTAL AMOUNT OF \$54,760,546 FOR THE FISCAL YEAR BEGINNING JULY 1, 2010?"

The Adjourned Annual Town Budget Meeting will reconvene at 8:30 p.m. at the Stonington Town Hall, 152 Elm St., Stonington on Thursday, May 6, 2010.


"IN ACCORDANCE WITH THE PROVISIONS OF SECTION 7-7 OF THE GENERAL STATUTES OF CONNECTICUT THE FIRST ITEM ON THE CALL OF THE ANNUAL TOWN BUDGET MEETING CALLED FOR APRIL 28, 2010 BE SUBMITTED TO PERSONS QUALIFIED TO VOTE IN TOWN MEETINGS OF THE TOWN OF STONINGTON FOR A VOTE UPON THE VOTING MACHINES IN THE SEVERAL VOTING DISTRICTS OF SAID TOWN ON MAY 6, 2010 BETWEEN THE HOURS OF 6AM AND 8PM AND THAT AT THE CONCLUSION OF THIS MEETING, SUCH MEETING SHALL STAND ADJOURNED TO RECONVENE ON MAY 6, 2010 AT 8:30 P.M. AT THE STONINGTON TOWN HALL TO RECEIVE SUCH VOTE AND THAT SAID ITEM SHALL BE PLACED UPON THE VOTING MACHINES UNDER THE FOLLOWING HEADING:

"SHALL THE TOWN OF STONINGTON MAKE APPROPRIATIONS IN THE TOTAL AMOUNT OF \$54,760,546. FOR THE FISCAL YEAR BEGINNING JULY 1, 2010?"

The motion being properly made by Mr. George Sylvestre, seconded and hearing no objection, the Moderator declared since there was no further business on the Call of the meeting, upon motion properly made by Mr. George Sylvestre, seconded, and unanimously passed the Moderator declared the meeting adjourned at 7:10 p.m. to reconvene on May 6, 2010 at the Stonington Town Hall at 8:30 p.m.
