 - Hook-up Charge
 - R. Cody moved to send a letter to the owner of Liberty Crossing confirming that the hook-up charge in the amount of \$352,150.08 paid on April 29, 2008, will satisfy all but the "unit charge" component of the total hook-up charge (as defined by section 12.09 of the Rules and Regulations of the Water Pollution Control Authority); that the hook-up charge, exclusive of the unit charge, will not increase in the future; and the charge paid may be assigned to future owners of the subject parcel.
