### Regular Meeting - September 25, 2012

A Regular Meeting of the Water Pollution Control Authority was held September 25, 2012, at the Stonington Police Station Meeting Room.

**Members in attendance:** James Sisk, Chairman: Peter Balestracci, member; Richard Cody, member; James Petrosky, member; and Lynn Young, member. Also present: Thomas Gilligan, Director.

- 1. Chairman Sisk called the meeting to order at 6:30 p.m.

- Contract operations United Water Representing United Water: Steve Wold Reviewed United Water Monthly Report – August 2012
  - As requested, the report includes listing of Sonitrol/SCADA monitoring points for each sewer District.
- 4. Wastewater Treatment Plant Improvements
  Representing CDM Smith and CDM Constructors Inc: Bob Blake and Bryan Benoit
  Comments additional to submitted report;
  - Negotiations with Siemens completed.
- 5. Comments from the public
  - a. Mr. Robert Birmingham Plan on Conservation & Development Advisory
     Committee. Mr. Birmingham provided introduction to 2 year process to update
     2004 Plan and need for coordination with the WPCA during this update process.
  - b. Mr. Ed Hart
    - Questioned impact of Misquamicut sewer to Westerly WWTP on Pawcatuck River. T. Gilligan responded with his understanding of significant reduction (50 – 75%) in nitrogen loading to River over the past 5 – 8 years as a result of facility upgrades/improvements on both sides of the River.
    - Raised concern about cost for new building at Mystic WPCF compared to total
      project cost. J. Sisk advised that BioMag process building has been in project
      plan since process selection and that a change in building design (block
      building to pre-engineered metal siding building) has reduced building cost
      substantially.
    - Raised concern with comments in press that would appear that a tie-in by North Stonington is proceeding without Town of Stonington resident input. J. Sisk advised that press is relating views of one party and that no such decision has been made by the Stonington WPCA.
- 6. Bills:
  - a. CDMS Design-Build Invoice Appl. #3 of Design-Build Agreement: \$250,041.14 5% Retainage = \$237,539.08
  - R. Cody moved to pay above bill. L. Young, seconded. Motion carried 5-0.
