BILLS

VOTE: Bob made a motion to approve \$43,205.40 for an invoice from Marino Construction associated with the Pine Bluff Recreational Facilities Project, Mike seconded. The vote was 5 - 0.

ATM WARRANT ARTICLES

VOTE: Bob made a motion to endorse warrant article # 33 (the transfer of \$34,000 from the budget for administrative expenses), Dot seconded. The vote was 5 - 0.

VOTE: Bob made a motion to endorse warrant article # 34 in order to transfer \$75,000 to each of the three buckets from the budget (\$225,000), Dot seconded. The vote was 5 - 0.

VOTE: Mike made a motion to endorse warrant article # 45 which will transfer \$140,000 of CPA funds from the Open Space Account to help purchase the Brewer property on Tuttle Lane, Bob seconded. The vote was 5 - 0.

VOTE: Bob made a motion to endorse warrant article # 46 which will transfer \$25,000 of CPA funds from the Open Space Account to help map and control invasive species, Mike seconded. The vote was 5 - 0.

Brian and Vin arrived at 7:42 pm

DISCUSSION: Kathy informed the committee that she will be doing the presentation at Town Meeting for the Tuttle Lane Land Acquisition article and will also present the CPA numbers. Vin will be giving the CPC recommendation for Tuttle Lane. Kathy also informed the committee that Cortni will be doing

the presentation at Town Meeting for the Invasive Species Mapping and Control article. Mike will be giving the CPC recommendation.
