**7:40 PM: Call to Order**

- After a duly published notice, the Capital Planning Committee convened in the Warren Room at the Town Building and the meeting was called to order.
- Attendance: Committee members: Dave Arsenault, Charlie Kern, Ross Perry, Myie Yvanovich, Steve Jelinek. Associate members: Michelle Mase, Ed Steinfeld
- The minutes of the February 28, 2013 meeting that were distributed to Committee members via email prior to the meeting were reviewed. A motion to accept the meeting minutes as amended was made by Charlie Kern, seconded by Dave Arsenault and unanimously approved.

**7:45 PM Review of Capital Requests**

**Planning Department – Karen Keliher**

**\$150.0 Lower Village Traffic Study**

- Requesting funds to complete construction drawings/plans for Lower Village Traffic planning in preparation of submission of MassWorks Grant (to fund construction)
  - Grant application – September 2013/shovel ready for March 2014
  - Plan will improve drainage, sidewalks and address traffic issues
- Total expenditure to date for traffic study approximately \$100K/\$40K granted last year/\$10K remaining
- Primary benefit to the taxpayer?
  - Better economic area in Stow
- Can this be delayed or phased?
  - A delay may mean missing an opportunity for a MassWorks grant
  - Delay may affect other improvements to the lower village
  - Cannot be phased as the funds are intended for construction drawings

**Purchase of land – 323 Great Road**

- Listed price \$369K/assessed value \$250K
- Planning Department is having property appraised
- Prime location/center of town
- Public meeting was held – potential uses include well site for municipal use; Fire Department; affordable housing; open land
- Discussion of use of CPC funds

**NHRS – Bill Cleary**

**2013 summary: Hale AC complete**

Roof on well station – work will be completed this spring/have three bids for work in \$9.9 – 11.5K range

**Hale Smoke Detector Replacement - \$35K**

- Includes replacement of duct detectors annunciators and batteries
- Existing equipment is over 15 years old
- Equipment cleaned last year
- 4 – 5 trouble alarms this school year
- Bill will look into separating annunciator and detector work
- Consider this to be top priority

**Hale Driveway – Hartley Road - \$90K**

- Repair Hartley Road – responsibility of school per lease agreement
- Two options:
  - \$56K to repave/repair – short term solution to problem
  - \$90K to grind surface/repave including small parking area on left as you approach the school
- Bill Cleary will consult with Highway Dept.
- Priority #2

**Hale Elevator Repairs \$15K**

- Elevator shut down between floors with students in car
- Elevator board is obsolete
- Equipment needs to be evaluated and repaired
- Priority #3

**Windows/Exterior Sheathing \$20K**

- Classroom ring mildew odor warranted investigation found sealant on edge of aluminum windows and the stucco is gone water is penetrating building
- Seal windows in critical areas/second floor windows
- Critical areas mainly on north side of building
- Priority #4

**Underground Oil Tank Removal \$18K**

- Gas boilers/no longer using oil
- 8,000 gallon tank needs to be removed/over 15 years old
- Believes tank is in a vault
- Will investigate option of abandoning tank in place/will contact conservation commission
- Priority #5
