Discussion of Reserve Fund Transfer Requests

Patricia Heron recommended approval of Article 20. Charles Kern seconded the motion. The vote carried unanimously.

Article 21 - <u>Town Election</u>

No vote taken or required.

Discussion of Article 3

The Finance Committee members agreed that they support the concept of perpetuating increase.

Jason questioned the retroactive increase to July for FY06. If the district came to us and asked for permission to raise salaries it would be a very large discussion.

They had inconsistent data and a delay of information. It did not make it to Town Meeting.

Linda asked if it would be more palatable to bring it back in May of 2006.

Jason stated he would struggle with it.

Pam stated that she was surprised it was retroactive.

Dave stated he doesn't agree with retroactive.

Jason stated he doesn't believe it was stated that we will address this in October.

Patti stated that people were told there was a salary adjustment going on and it was inappropriate to make adjustments before the salary survey was complete.

Steve suggested if we implied a promise we should make good on it.

Jason said he would like to get a sense of what a fully loaded cost would look like and will it increase Article 3 or is the money already there to cover it.

Pam stated that she would like to see a list of increase before the vote.

Jason asks Henry how many positions are affected overall.

Henry stated 22.

Jason asked what the percentage is and how the town will fair.

Henry stated the percentage is 80% good and 20% are out of range.

A motion to adjourn was made by Patricia Heron and seconded by Charles Kern at 9:25 pm. The motion carried unanimously.
