STOW FINANCE COMMITTEE

Public Hearing March 19, 2009 7:00 PM Town Building Approved

Call to Order

Charles Kern called the meeting to order at 7:20 pm. Present were, David Walrath, James Salvie, Ann Deluty, Christopher Sarno and Elizabeth Tobey, Secretary.

Charlie explained that the purpose of the Public Hearing is to listen to the people on concerns with the Town Warrant. The Warrant had not been approved and has handed out a Preliminary Copy of the Warrant.

Ellen Sturgis stated that the Elementary School Building Committee in 2007 had taken a vote for the Center School renovation for the best proposal. Bond Counsel has stated to them that they cannot spend any of the money on Pompositicut Elementary School. The MSBA has not responded regarding Pompositicut School.

The MSBA has given notice that some study may be done on Pompo. They are hoping for a change in the article language to include Pompo, strictly to loosen a phrase on the proposal.

Ellen stated that she is unsure how much has been spent to date. MSBA is supportive of the Master Plan. Nothing is on paper yet. They want to make sure the report is up to date and that they have the money to do it.

Jim asked if the MSBA are leaning toward 2 schools. Do they want something as to why we are not considering it? Ellen's answer was yes.

Ellen stated that Article 37. School Building 2 – Add \$80,000 to ESBC acct, if necessary, has been removed from the warrant.

Charlie explained that there is a 3% cost of living adjustment this year.

Janet Stiles asked to speak about the Recreation Commissions personnel budget. She stated that she feels the position of Recreation Director should be eliminated. The 45k full time position is fully benefited and appointed by the Recreation Commission. She suggested that Bolton and Harvard recreation activities are all run by volunteers that perform the same duties that our recreation department does. The duties can be divided into 3 categories; Seasonal, Fees and Contracts and League Management. We shouldn't have to pay for it, people using the services should direct them.

Janet Stiles also stated that she feels there should be a freeze on all salaries.

Laura Spears explained that the Historical Commission approved the historical properties that are to be inventoried. The commission has talked to a consultant and stated that there is much more information on the new surveys.

Laura Spear explained that the Musket has belonged to a Stow family through generations. It is for sale now. There has been an independent appraisal on the Musket. The Minutemen will pay 50% and the other 50% will be with CPA funds. The musket will then belong to the town. A volunteer offered to make a case for the Musket.

Charlie stated that the article is to create the stabilization fund this year. It is not to fund it this year. If it passes they will need 2/3 of the school committee vote to spend the funds as apposed to going to Town Meeting for approval.

Jim Salvie asked if they really believe at any dollar amount people are subject to intimidation if they don't vote they way others want them to.

Bill suggested that he had heard rumors that there has been intimidation. There have been children making comments to other children that their parents didn't vote right. He also stated that there are resident/businesses owners in town that will not vote for fear of losing customers.

Jim asked if intimidation is the problem is there a more feasible solution. What if we gave the Moderator the power to call a paper ballot at his discretion?

Bill stated that the moderator has the power now to accept or refuse a paper ballot. We want to eliminate the power of the moderator. He now has full control over the meeting.
