Gary explained that if the Stone Building passes they cannot go out to bid on the current time schedule. SMMA has to draw up the new designs. However long that takes is how long they will take to make a decision the monies are already encumbered unless they find an error, they would then take it back. The project has to start the day after school closes. That can't be done if the plans have to be changed. If they can't start this summer they will have to wait a year. The MSBA meets one time a month. They will lose the summer which means they will have to wait to start until the following year. They will need full construction documents for a change in scope. All of this will delay construction.

Gary Bernklow moved to recommend to Town Meeting that they should not approve Article 38. David Walrath seconded the motion.
