Nashoba Regional School District

There was a brief discussion between members regarding what the responsibilities of the Liaison to Nashoba should expect when attending meetings. Tom stated that labor relations start in the summer and he will get an update on them. The Medicare Bill money is suppose to go to education, states are counting on the money to offset their shortages.

Council On Aging

Beth explained to the committee that the COA Board had approved the Friends of the Council on Aging, purchasing a used 20 passenger shuttle van/bus from a dealer in NH. It has approx 60k miles on it, which is considerably low compared to most of the vans that they looked at. The cost of the van is \$28,500. They are also purchasing an extended warrantee at a cost of \$1,950, that will extend the mileage another 70k miles or 24 months, whichever comes first.

Massachusetts School Building Association

Rick Connelly explained the 6 bids add-alternates came in slightly lower than was expected.

Chris explained that the MSBA would only reimburse for things that they deem prudent. ie: root screening, approved approx \$200k, it is not necessary usually. If they were ugly, to pay full cost later would not be prudent.
