They are only allowed to charge a certain amount per town. Some towns send a large amount of students but are not part of the regional agreement. This is favorable to small towns and helps Stow. Kate Hogan has been helpful to get the state law passed to coax more towns to become members. They have tight deadlines. Some sort of plan will be approved by July. 40% of the students are out of district. If the town is not a member of the vocational school the town has to pay the tuition if their student wants to go to that school.

*ESBC* – Rick Rollins explained that the construction company is one month behind. December 13, 2011 was the original date to finish. They are now looking at the end of the year to finish work and move students, around January 16, 2012. Phase one is at 75% of budget and phase two is budgeted at 20% or less. Some materials are already purchased for phase 2.
