Liaison Assignments

POMPO-

- It is a huge building and they will have trouble finding leasers.
- The architect states that seismic requirements they will have is an essential aspect that needs to be working according to seismic codes.
- The cost of demolishing the building equals 1mil
- Mostly ledge under the building
- There is a savings in reusing Pompo
- Full construction Reno is \$9.5mil
- Demo and rebuild 14k sq. ft. building \$6mil
- Bare minimum completed to move in \$2.5mil
- Postponement would buy the time to see all of the options for all buildings
- If nothing is approved the cost will be \$50k to fund to next Town Meeting

FIRE-

Members discussed the need for a new Fire Station and the desire for them to remain at the current location.

LIBRARY-

It was commented that library use has gone down state wide. The back of the building is not up to code. They cannot put the stacks there. It is a community gathering place. Thursday there will be an open public forum for the library.
