Minutes Finance Committee February 12, 2013 Final

Call to Order

Chairman Peter McManus called the meeting to order at 7:00pm. Present were,

Budget Reviews

7:30 - Highway Department

Mike explained that last year they spent \$100k on capital projects.

This year they are asking for \$163k

- 1. \$98k is to replace a one ton truck with a low profile multi-purpose truck that has 2 different interchangeable bodies, enabling them to easily change the trucks function. They are not adding a new truck.
- 2. \$65k to move the existing modular classroom from the Pompo School to the Highway garage to be utilized for office space. To include; Construction cost to connect the modular to the Highway Building, construction of restroom facility within the modular, turning the existing office into an employee locker room and bunk room, all electrical, plumbing and septic associate with the connection of the buildings, and purchase of used furnishings.

This past storm cost \$32k for clean-up for this one storm: i.e., driver labor included per-diem employee who will be stepping down and replaced with a new employee.

Mike exited at 7:55pm

8:00 - Police Department

Rachel and members discussed the professional development for officers training, liabilities down the line, capital projects and the Emergency Notice System and the costs. They will continue to replace one vehicle per year.

The new explorer fits all of the necessary equipment. The fuel cost is a 1 mile per gallon difference between the Taurus and the previous explorer.

8:30 - Nashoba Regional School District

Rick Rollins recused himself from the discussion regarding Special Education Christopher Sarno recused himself from the discussion of Nashoba Regional School District.

Operating Budget- George explained:

- There is a rise of 3.88% in the budget.
- The cost is driven by the salaries.
- There are increases in the Facilities Department.
- Small repairs at the high school.
- Net six positions being added
 - 1. Special Ed at Hale
 - 2. Sports at Sawyer School
 - 3. Special Ed at Nashoba
 - 4. English in the High School
 - 5. Technology Department addition

Payroll has increased 4% step increase plus 1.5% COLA increase \$36mil fixed assessment

Bolton had 67 students missed in the assessment. They are now required to assess on the numbers they gave rather than the actual count.

Stow's assessment is 5.09; the budget is up 3.88%)

When the students are added back into Bolton's figures, they will have to assess.

Chris commented that the facilities had increased 8% of the budget; it's a big baseline increase. \$295K scheduled maintenance.

Mr. King explained that it is scheduled maintenance plan that is followed each year to maintain the facilities.

Mr. King stated that he had worked up proposed baseline but is not ready to present it. There is reluctance in town to issue a bond.

- We are thinking about adding another bus in Stow.
- There is no fuel escalator in the contract.
- The governor's budget could impact the school budget.
- The Tech Dept. Salaries are for the people who run the systems.
- School Choice, Pre-school and tuitions are moved to offset.
- No capital project grants.
- High School Capital is roofs, windows and heating issues.

Nashoba - Renovations in the past did not touch the classrooms *Hale* – Is in good shape overall.

- At some point the elevator will need repair approx. \$215k.
- We switched over to gas 3 years ago.
- Will need to remove the oil tank \$18k
- Pot holes on Hartley road need repair
- New auditorium curtain
- Re-key entire building all doors
- Window replacements

Capital – some replacement of windows, smoke detectors and Fire alarms systems.

When asked about solar Mr. King said, "it is a complicated thing. At best we will break even."

When asked for an estimated time frame for capital, Mr. King replied, "Not this Town Meeting. Over the next year we will start the discussions. We will be looking for ideas from the towns.

Members commented that the cost per pupil is very high. The numbers in cost and test scores has got to improve.
