Randall Library – Salaries and Wages-\$1,208.08

Melissa Fournier explained that she has;

- Changed the Children's Librarian's totals to a lower amount. The new librarian is bilingual.
- The state requirements are based on the size of the community you to spend a
 percentage, 19% of then municipal budgets. As the salaries go up that number
 goes up. The library must reach the number per year to receive certification. If
 not they will no longer be part of the Minuteman Network.
- Franklin lost their certification.

Building

Craig Martin explained that he has;

- In 2012 \$109k was budgeted. He brought in \$56k in permit fees. He is proposing to increase the plumbing fitting and wire fees \$5 per 1,000 for 20 years.
- Review of payroll- There is an assistant building inspector and outside contract if help is needed. Along with training money and supplies.
- Capital items:

<u>Boiler</u> - A situation developed from the school district. A boiler went down at Hale School that was unanticipated, over \$10k. The town pays for anything over \$10k. The repairs were completed while the kids were out of school. The District didn't have the funds. The contractor is waiting for payment. Craig plans on taking it to Town Meeting and explaining to the residents.

<u>Water Treatment System</u> – The public water supply under DEP in Worcester located in the back of the Town Building has high iron and magnesium levels 8.5 to 9. It affects the water and the taste. Consultants advised \$29k to fix it. The iron is up around 11. There is a difference in how you treat. Have priority systems that DEP approves. There is a new engineer with new designs, which are the least expensive system. Need chlorine to remove the PH. The new system plan, DEP gave until Nov.2013 to get it done. DEP said it needs more than the norm because of the levels.

 Appraisal for 323 Great Road Property, which will be included on the Annual Town Meeting Warrant for purchase or an option to purchase for municipal use. Potential uses for the property under consideration are Fire Station/Well Site/Open Space OR Affordable Housing/Well Site/Open Space. We are in receipt of a quote in the amount of \$2,500.00 from Avery and Associates. CPA Funds will be used for half of the cost as a portion of the land is being considered for a well and open space. Because the other half of the property could be potentially for a Fire Station and not Affordable Housing, CPC funds cannot be used to fund the entire appraisal.
- 5. This expenditure is extraordinary and/or unforeseen for the following reason:

 We were not aware of the potential sale of this property when preparing the FY2013 budget. This is a unique opportunity for the town to purchase property in a prime location in the center of Town, with a real potential for either siting a Fire Station or Affordable Housing Units as well as reserving an area to locate a well to serve municipal buildings and a water source for sprinkler systems for town buildings. If it is determined that this site is feasible for a Fire Station it is anticipated that it would be a cost savings from plans to rebuild on the existing site in terms of demolition and temporary housing costs. Access to water could result in cost savings for sprinkler systems that will be required for Library, Church and Fire Department capital projects. As an alternative, the Stow Municipal Affordable Housing Trust is very interested in the property for an affordable housing development in which case purchase of the entire parcel can be funded with CPA Funds. With either scenario, a portion of the purchase price (area comprised of a well and open space) could be funded with CPA Funds.
