**New and Associate members:** Dot has heard from a Stow citizen who might like to become an associate member. She will extend an invitation to that person to attend the October 8, meeting.

**Old and New Business:** Dot received a notice that on Thursday, Sept. 24, 2015 there will be a MA Historic Conservation workshop held in Blackstone, MA from 4-6pm. Also, Dick Gelpe will be hosting a talk about Lake Boon on Sept. 23 at the Sudbury Wildlife preserve. The Maynard Historical Commission will hold a dedication ceremony of the Glenwood Cemetery Perimeter Iron fence at 10 am on Oct. 3 as part of Maynardfest.

**Correspondence**: Dot Spaulding, chair, received a forwarded letter informing the Town of Stow of the owners intent to put "Hosmer's Folly" at 4 Red Acre Rd. up for sale sometime soon, and inquiring about town interest. Also the Stow highway dept. is cleaning up the old Town Barn on Crescent St. and there might be forgotten historical contents. Dot will try to schedule a walk-through for Commission members to photograph and list the contents which might be historic.
