## Meeting Minutes

The Commission reviewed past meeting minutes.

 John Sangermano made a motion to approve March 31, 2015 meeting minutes as drafted, Eric Bachtell seconded the motion and board voted in favor 3-0 to approve minutes.

## Pine Bluff Improvement Project

- Laura gave the Commission an update on the Pine Bluff project.

Construction at Pine Bluff started on April 13, 2015

 All of the trees involving the building project has been taken down and the stumps have been removed or grinded where needed.

The soccer storage shed has been relocated

- The soccer kick wall has been taken down and moved to its new location.

The water in the shed has been turned on.

- Board reviewed a funding plan for the additional work needed to be complete at Pine Bluff.

- Eric made a motion to have Laura continue to negotiate price for deck retaining wall and deck completion and proceed if permitted by MA general law proceed if 35k. John seconded the motion, board voted 3-0 in favor of the motion.
- Eric made a motion to purchase a shade structure in the amount not to exceed \$3700 using revolving account funds. John seconded the motion and board voted in favor 3-0.
