PUBLIC NOTICE STRATHAM BOARD OF SELECTMEN

THERE WILL BE A PUBLIC HEARING HELD ON MONDAY, FEBRUARY 13, 2012 AT 7:30 PM IN THE STRATHAM MUNICIPAL CENTER, 10 BUNKER HILL AVENUE, CONCERNING THE TOWN OF STRATHAM 2012 TOWN WARRANT. SPECIFIC ITEMS TO BE DISCUSSED INCLUDE BUT ARE NOT NECESSARILY LIMITED TO THE FOLLOWING:

- 1. PROPOSED 2012 TOWN OPERATING BUDGET.
- 2. PROPOSED 2012 CAPITAL IMPROVEMENTS PROGRAM.
- 3. THE PURCHASE OF A PORTION OF THE PROPERTY AT 97 PORTSMOUTH AVENUE (TAX MAP 13, LOT 37) ADJACENT TO MAPLE LANE CEMETERY AS PART OF A FUTURE EXPANSION OF THE PUBLIC CEMETERY.
- 4. CREATE AND FUND AN EXPENDABLE MAINTENANCE TRUST FUND FOR THE CARE AND MAINTENANCE OF TOWN BUILDINGS AND GROUNDS.
- 5. THE PURCHASE OF A NEW FIRE TANKER BY AUTHORIZING THE USE OF FUNDS FROM THE "STRATHAM FIRE DEPARTMENT EMS FUND" AND THE "FIRE DEPARTMENT VEHICLES CAPITAL RESERVE FUND" AND THE ACCEPTANCE OF DONATIONS TOWARDS THIS PURCHASE.
- 6. THE FUNDING OF FIRE DEPARTMENT TRAINING BY AUTHORIZING THE USE OF FUNDS FROM THE "STRATHAM FIRE DEPARTMENT EMS FUND."
- 7. A SPECIAL WARRANT ARTICLE TO FUND CONTRIBUTIONS TO THE "ACCRUED BENEFITS LIABILITY EXPENDABLE TRUST FUND."
- 8. A SPECIAL WARRANT ARTICLE TO FUND WRITING AND PUBLISHING OF AN UPDATED TOWN HISTORY.
- 9. ANY OTHER SPECIAL AND/OR PETITION WARRANT ARTICLES TO APPEAR ON THE 2012 WARRANT.
- 10. ANY OTHER ITEMS TO APPEAR ON THE 2012 TOWN WARRANT.

THE STRATHAM BOARD OF SELECTMEN INVITE ALL RESIDENTS OF TOWN TO ATTEND THIS PUBLIC HEARING AND WILL BE PRESENT TO ANSWER ANY QUESTIONS. SHOULD IT BE NECESSARY, A SECOND HEARING ON THE 2012 TOWN WARRANT IS SCHEDULED FOR MONDAY, FEBRUARY 20, 2012 AT 7:30 PM AT THE STRATHAM MUNICIPAL CENTER. THE NEED FOR THIS SECOND HEARING WILL BE DETERMINED AT THE FEBRUARY 13, 2012 HEARING.
