<u>Southbridge Landfill</u> A letter from State Rep Todd Smola was submitted to DEP on behalf of the town with their concerns on the proposed expansion of the Southbridge Landfill. Numerous Homes on H Foote Road in Charlton have contaminated wells. Jon Sanborn is a concerned Charlton Resident asked what they test for. Do any of the monitoring wells have exceedances?

Linda Cocalis read in the report that there are contaminants in the monitoring well reports in the unlined portion of the landfill. H Foote Road abuts the lined portion? The expansion is proposed for the unlined portion. Charlton residents should not bathe for the toxins can enter the body thru the skin. You can't expect the EPA DEP to help us we are on our own. We will hold a citizens forum with the State Representatives, other State agencies and all interested residents on Monday November 30<sup>th</sup> @6:30pm
