Motion made by Joe Ouellette: "To raise and appropriate CPA funds in the amount of \$64,235.00 to fund: a) River Lands Trail Head Parking Lot Construction (Stallion Hill Rd) And Related Parking and Trail Construction Expenses, b) Leadmine Mountain and Heins Farm Trails Construction, Design, Permitting and Related expenses, c) River Lands Trail Segment 1 & 2 trail construction rough-in, design, permitting and related expenses, as submitted by Sturbridge Trails Committee in their FY2012 CPA budget request". Historic Commission Request for CPA Funding	JOuellette presented a proposal for the digitization of historic OSV documents relating to the town of Sturbridge (Tillyer Papers). He explained that this was an initiative by the Historic Commission to work closer with OSV to further preserve as much of the written history of Sturbridge as possible. This project calls for the digitization of the Tillyer Papers, a collection of approximately 4,000 documents relating to the town. These include tax records, deeds teaching certificates petitions to the town meeting, welfare requests, indentures, militia lists from the late 18 th through the mid 19 th centuries.
