#### **Committee Updates:**

• CPA: not met

Trail Committee: GC discussed

- Red Trail (intermittent stream, suggested a bridge vs. culvert. Must file NOI since in wetland and since outside the previous Order of Conditions covered proposed at Leadmine Mountain
- Arbutus Park Trail around Camp Robinson Caruso: regrading (for water drainage) and realigning (50' for water drainage) on that trail and staging work in prep for this weekend. Work on Sat 28<sup>th</sup> and spread crushed stone to further meet ADA compliant trail.
- o logging plan on OSV/Leadmine not discussed.
- Lakes Advisory Committee: not met

#### Walk-Ins:

#### Dave (John) Holdcraft – 44 Allen Rd, Sturbridge:

- Question on 96 Allen (Seth LaJoy) how much went into pond: CM responded about 40 cubic feet of sediment into pond.
- Issue at 35 South Shore Drive, Seguin's, road washing out. 31 South Shore is where trouble is starting, since built been keeping culvert open. Mr. Holdcroft said that Shore Drive resident brought in a bale of hay and he is helping beavers to build dam. Has been going on since 2010, what is commission going to do about it? DG never saw water from Allard's property during construction. DG unaware that the BOH has ordered him to keep culvert open. GC hasn't asked Allard directly if he is doing this, but probable as the hay bale has appeared on the road and on the dam. This is not beaver activity. EG, feels no assumptions of who should be called out. CM: what is GC's suggestion: Allard is complying w/BOH to keep culvert open, but he is altering a wetland (filling, cutting vegetation, damming). No commissioner has proof that he is altering wetlands but letter could request he remove the hay bale. Water backing into Holdcraft's property. Trees falling from soft ground. Water has been backed up for a long time. Commission can act on hay bale and non-beaver related (brush and logs being dropped on dam). BOH or Fish and Wildlife can request dam be removed. Non beaver related brush along with hay.
- GC site visit with Linda Cocalis today and this property is not the only prop effected (35 S. Shore/ Seguin's).
- Read a Letter (copy sent to Holcraft) sent to Seguin's, dated, 3/21/12, BOH granted work to be conducted at 31 Allen Rd by clearing debris by inlet pipe to South Shore Drive and to maintain it in a matter so that it shall remain free running and clear.
- Commission can ask Allard to remove hay from the dam. Other than that it's out of Conservation's jurisdiction. DEP won't get involved as it's between two personal properties. Agent to get clarification of the BOH letter, regarding maintaining clear pipe.
- DG excused herself from the meeting.

#### **Public Hearings:**

7:05 pm: NOI DEP#300-872, 62 Mt. Dan Rd, Daniel and Shannon St. Onge; Peter Lavesque, Pioneer Environmental; Don Frydryk, Sherman and Frydryk Engineering; Jason Pecoy, Pecoy Companies

- Revisions to plan and site visit (last Thurs) of requested changes, drew back retaining wall of the original approved plan and back to 25' no disturb zone. Added 2 additional plantings w/in 25' buffer zone.
- Stormwater runoff area totals 1330sf. Half-inch storm would fill infiltration area .2-feet, with plenty of extra capacity. No soil test borings for the wall were done. Installing imperious stone pavers with pea stone to deal with water coming down the driveway and stairs. Lakeside of property has gutters; other side goes into stone areas. Foundation went down 12'.

7:30 pm: Bluewave Capital Solar Project NOI#300-TBD; Hare Road/Hobbs Brook Plaza

**Attendees:** Sam Moffett- TRC, Jaime Walker – Wetlands Scientist TRC, Rob Jackson – Engineer TRC, Anne Reitmayer – Bluewave,

- Legal notice & abutter notification handed to Agent.
- Scope: Located off Hare Rd, near Hobbs Brook, occupying some land owned by State of MA, under control of MA DOT. Total site under 100 acres. Proposing to use 11 acres of that space to accommodate solar project (sized at 3 megawatts). NOI contains wetland report. Site has streams, boarding vegetated wetlands and vernal pools. 5 areas for solar arrays numbered: #1 through #5, with #1 western most area #5 eastern most point. Site developed with access using Hare Road and George Vinton Road (currently a paper road) may use as access road with upgrading by adding culverting stream crossings. Lot of solar on a small footprint w/minimized impacts to wetland areas. Working on plan to submit to planning board shortly. Open to suggestions in working together w/town.
- Commission Questions:
  - Clarification: Square foot of arrays add up to 654,000 SF = 15 acres not 11 acres.
  - o plan C1-A: array #1: Does usable area include all hash marks? Yes.
  - Grading plans 16' from lower level to upper level. Creating plateaus to work with the arrays.
     Water table: varies shallow to deep
  - Crossing Two crossing on George Vinton Road. Will these crossings be improved? Grass species
    picked to provide good habitat for birds. Will require mowing schedule to consider nesting birds.
- Foundation for racking system: 10'deep. 13 borings taken and submitting a geotechnical plan
- Usage area: limited tree cutting and disturbance inside the 50' buffer zone. No work in 100' industrial setback zone. Disturbance only in solar array areas. Areas where trees would be removed and/or replaced to be shown on next set of plans.
- Access point: proposing George Vinton Rd to be access point must still go to Planning Board. Paper road
  built but dirt and paved in spots. Upgrade existing culverts, stone culvert isn't sufficient at array #2. Replace
  culverts at crossings of George Vinton Road. Road will be made of pervious metal (steel mesh) material
  placed into the road surface, like a honeycomb. Road will be plowed, sanded in the winter. Array areas will
  be fenced with an 8" gap for critters to migrate between uplands and wetlands. Some of the wetlands are
  vernal pools.

- Flood Plain: 100yr FEMA flood plain isn't noted on plan for the arrays. Any loss of flood storage capacity would require compensatory flood storage
- Array is a racking system. Multiple panels racked on single rack.
- Flagging is complete and Commission to do a site visit. GC site visit, noted some orange flags that had no numbers, what do they represent in the field. Pink and Blue flags are Bwave. Orange is surveyor's flags for topography.
- DB requesting a 3<sup>rd</sup> party to review this project as it's a large project.
- One invasive species fragmities in area of Hobbs Brook. Nothing found for endangered species.
- Discussed other projects that Bluewave is involved in currently; Rochester, MA (New Bedford area): 31 North Ave; same as regs specified in our project. Using vegetative coverage vs. gravel.

Commission will do a site visit before next meeting. BWave must be aware of Commission visit per DOT requirements. Request for continuation for next meeting 10/3 no time yet appx 8:30pm

# 8pm William Emerson, 248 Big Alum road, landscaping and stair lift system. William parker c/o William Emerson. All proposed plans: planting, budget not finalized.

Scope: lot had been heavily forested with hemlock trees, all trees removed by homeowner over the past 5 yrs. Final Scope of project: will be based on the applicant's budget. Will need a site visit. Cottage owned by owners in their early 80's; need a way of easier access for homeowner; proposed stair lift. Proposed stone stair for use now and a stair lift for use later in their life. 3 proposals for review; most favored plan would be proposed construction drawing. No removal of trees on plans. Low voltage lighting will be installed along stairs. Will provide a final plan prior to site visit and mark out chair lift w/two stakes and a string. Request for continuation on 10/3 at 9pm.

- Stone berm is installed; almost 4'ht. Driveway not finished yet
- Feel site stable and secure; want a report of grading at the next meeting.
