Detail Specifications: Sign: Non-Illuminated Channel Letters; 5"D on .040 Aluminum in white used on sides and back of sign; 1/8" Plexiglas faces with HP orange & purple vinyl overlays for front of sign; 1" plastic edge trim; Mounted to building fascia via 1/4" x2" lag screws Colors: Logo/Wording: Vinyl di-cut letters; orange and purple; "E(in orange)verybodys 24/7 (in purple) Fitness Center (in orange)"; Background: white NOTE: the applicant/tenant realized that the color sample provided was a bit brighter in hue than what will actually appear on the sign. A member of the DRC was concerned with the deep purple and bright orange sample chips that were provided. The tenant's intention is to match the "Right Aid" blue and the "Shaws" red/orange.

Address: Existing; bottom of sign; centered Size: 32"h x 132"l

Lighting: using existing strip of lighting at bottom of sign; attached to facade of building

Question: Was there a temporary sign permit approved as this tenant currently has a banner sign currently installed on the building and (2) additional signs installed in the window? If not, the tenant is aware that one would need to be issued by the Building Inspector's office and will follow up with the Building Inspector's office.
