accurate paint chips and 2) manufacturer's specifications associated with the colors: number, manufacturer name
and/or color. The color sample we received illustrated a varying shade of a red and the lvory shade had notes
written on it, making it difficult to get an accurate visual sample. The color chips need to be turned into the
Planning Department and must match the existing color palette of this site; that requires it to be burgundy.

General Note: All applicants were made aware of the "next steps" in this process by the DRC as their respective signage is approved. Applicants will circle back with Planning, then over to the Building Inspector's office for a permit number to be issued and thus added to their sign.

New Business:

• **Mermaids Closet:** The applicant is requesting approval for a sign that was previously approved for property located at 392 Main Street to be permanently located at 425 Main Street, Unit 5. The DRC waited 10 minutes for the applicants to arrive to the meeting. Since neither owner attended the meeting, we are unable to approve as there was no prior approval to have their existing sign reinstalled at a different property. One committee member suggested a fine. However, the majority agreed that we strongly suggest the sign be removed until approved by the DRC at our next meeting on August 7th.
