Lastly, the lighting for these signs will need to be moved below the Sal’s Pizza Sign to below the new Sturbridge Seafood Sign.

**DRC Recommendation:** Provide appropriate landscaping around the existing pylon. (See Attached Photo)

**Detail Specifications:** M.D.O., clear pine mounted to existing sign post.

**Colors:** Sherwin Williams Black Wording and Trim, Sherwin Williams Bees Wax Accent, and Crab – a hand-painted indigenous color.

**Size:** Double faced sign 60” by 60” (25 sq. feet)

**Lighting:** Move the existing lights from below the Sal’s Pizza Sign to a position below the Sturbridge Seafood Sign.

**Detail Specifications:** M.D.O., clear pine mounted to wall.

**Colors:** Same colors as pylon sign.

**Size:** Single faced wall sign 72" X 60".

**Lighting:** Wall mounted white lighting directed downward onto the sign.
