Lighting: externally illuminated with existing light mounted at the top center of the pylon structure.

• Logo/Wording: "Antiques Collectables"; black copy; outlined in white; to be similar as shown in the pylon sign "Famous Antiques"; white copy; outlined in black. "& Furniture" white copy; outlined in black; to be similar as shown in pylon sign "Flea Market".

 Colors: Beige, Black & White (and possibly burgundy, please ref to below note); vinyl di cut color chips provided

Materials: aluminum; mounted to building

Lighting: none **Size:** 40"h x 96"l

Landscaping: Tenant agreed to have potted plants on the patio area.

Documents Reviewed: Sketch of sign; on file with Planning Department in Applicant's File **Note:** DRC members were concerned that tenant had two different signs (in color, overall style, font and wording), thus may be confusing to the public as seen as two different businesses. Tenant agreed to use the same font and color scheme as the pylon sign on the building sign but will retain the different wording. He was concerned that the beige sign on beige building wouldn't show, that's why he chose burgundy for the background. DRC has left it up to the tenant to choose between a black boarder or incorporate the burgundy color from his proposed building sign.

- Winebuyer's Outlet & Sturbridge Chocolate E Cook is concerned that the temporary A frame sign
 over the last few Saturdays has been put directly in the middle of the sidewalk. Concern for patron
 access along the sidewalk.
