DRC Comments: Ms. Edwards requested advice regarding ballard height, style and placement of fencing. She expressed a desire to be consistent with recommendations from the ongoing Gateway District studies, as well as a preference that these materials be consistent with the date of the building housing the Rovezzi Restaurant. She gave the committee a detailed explanation of her choice of plantings and why she has recommended removal of two old trees on the property.

DRC member Fran O'Connell is also a member of the Commercial Tourist District Committee and volunteered to bring the matter to that committee for further advise pertaining to the fencing.

Member Chris Castendyk requested three dimensional renderings of what the design will look like when completed and the applicant agreed it would be done.

The committee was impressed with her thorough presentation and feels the design will be an attribute not only to the restaurant, but to the proposed Gateway District Design.
