Materials Reviewed: Rendering of proposed sign and placement on multi tenant sign.

Colors proposed: White painted background Black and Green Graphics

DRC Comments/Conditions: Discussion relative to the proposed design, which included the business logo, business name, phone number, web site and four key words each bulleted by a shamrock, elicited differing comments by the DRC members. Two of the members favored a simpler, easier to read design, eliminating the four key words, enlarging the center placed logo and the business name text, with the phone number and web site centered of the sign.

One member favored the original design including the four key words while the fourth member was neutral but suggested a rewording of the key word "senior portraits" to one more indicative of the intended use for senior class portraits.

Motion to approve the design with the enlarged centered logo and the enlarged business name text, centered above the logo, the phone number and web site centered below. The key words may be retained or omitted at the discretion of the applicant, final design to be brought to the Town Planner. - By Chris Wilson and seconded by Chris Castendyk Vote - 4-0

Re: Update on Properties at Wight Farm, 425 Main Street

The application for design approval presented at the August 19, 2015 DRC meeting for a free standing, multi tenant sign on the property at 420 Main Street was tabled for further clarification as to the legality of the sign.

At today's meeting, Diane Trapasso from the Planning Office presented the Committee with a substitute proposal for a freestanding sign using the original post in place on the Cedar Street side entrance to the rear of the buildings. The new design replaces the original signage removing all of the business names listed and replacing them with a sign designating "Parking".

Materials reviewed: Rendering of the new proposed design showing the removal of the business signs and replacement with a "Parking" sign.

Motion to approve the new proposed freestanding parking sign replacing the current multi-tenant sign for the Collection at Wight Farm at 420 Main Street, to be installed off Cedar Street with the condition to add zone appropriate plantings to the base of the sign.
