Zone: Commercial Tourist District

Materials Reviewed:

- Photograph of existing property and landscaping
- Exterior color scheme
- Interior floor plans
- Exterior layout plan
- Proposed exterior changes:
- Removal of roof of existing second floor 3-season porch

- Replacement of sliding glass doors with paned window
- Installation of new first floor patio with posts and new roof shingled to mirror existing roof of main building
- Addition of handicap-accessible ramp
- Addition of a wood railing to match that of existing railing on main building
- Stonework to compliment color of Techo-Bloc pavers

Conformance with Design Standards:

- Height of main structure will not be affected by remodel
- Applicant to upgrade building front door consistent to existing architectural features of the building
- No proposed change to features to impact relationship between building and neighboring buildings or structures
- Other than new patio roof, no other roof changes are proposed
- No proposed changes to overall scale of building or structures
- No façade alterations are sought or proposed excepting those mentioned above

Lighting: Lighting plan incomplete at this time and samples were not available to the Committee.

Landscaping: The final Landscaping Plan will be presented for approval to the Planning Board.

The DRC compliments the comprehensive presentation given during this process. The Committee suggested incorporating a bench if appropriate to the landscaping design.

Building colors: Samples were presented to the Committee for the Main Building, which will be repainted with the following shades of gray:

Main Color of Building and Porch and Patio Railings: Zydeco C2-986

Trim Color: Shale C2-982

Porch Floor Board Color - Magnet C2-967

DRC Comments/Conditions: Porch and Patio railings to match main building color.
