#### Proposal:

• Addition of a new two sided sign to the existing multi-tenant post

#### Materials reviewed:

- Photo of proposed placement n existing post

• Google Earth photo of existing property indicating sign placement and office location

#### Sign dimensions:

• 48" x 62" (20.6 square feet)

#### Sign material:

• PVS signboard

#### Sign colors:

- Background gold with a green band across lower section
- Graphics Vinyl print
- Graphic colors: Green on the gold background, Gold on the Green background
- "Pest Control" graphics Green on white swirl background
- "Bug" logo Black

DRC Comments/Conditions: DRC members apprised Mr. Branniff of the Design Review Guidelines pointing to the preferred signage design of which he was aware. He stated his client's wishes to install the proposed sign, which match his vehicle signs using the same colors, and logo, which is a yellow background sign with bright green graphics. This rectangular sign is proposed to be positioned next to the existing "Brier Patch" sign, which is oval with black background and gold lettering.

The Committee and Mr. Branniff worked on alternate proposals to change the shape of the sign to be more complimentary to the Brier Patch sign. In addition to altering the shape of the proposed sign and adding a black border, the Committee put on a condition the sign be attached to the existing post to mirror the Brier Patch sign, that is to use the same black iron rod across the top with the addition of two black iron hangers to match the existing sign.

A number indicating the street address is to be attached to the post.

Mr. Branniff will draw up the new design, present to his client for approval and return to the DRC meeting of April 3, 2017
