Finance Committee Meeting Minutes Town Hall ~ April 18, 2017 Sturbridge, MA

Call to Order:

The chair called the meeting to order at 7:00pm. The following committee members were present: Kathleen Neal (KN), James Waddick (JW), Suzanne Smiley (SS), Joni Light (JL), Jared Burns (JB), Michael Serio (MS), Larry Morrison (LM), Bruce Boyson (BB), and Mike Hager (MH). JW excused himself from this meeting to attend the BOS Public Hearing on Douty Road and returned at 8:33pm.

Line Item Budget Review

KN noted that there is a correction on line 108 in the Board of Health (BOH) Inspections & Testing personnel costs. The amount was based upon 18 hours and should be based on 19 hours as per confirmation from the Finance Director. The amount should be \$23,950.00. JL made that adjustment in the budget line item file.

MS continued discussion on the BOH personnel concerns, and shared his conversation with Linda Cocalis, the BOH Director. It was suggested that she attend a future meeting to clarify additional questions.

Moving onto discussion on the Tree Warden's budget. JL voiced her concerns again on the pesticide treatment of ash trees in Sturbridge for the Emerald Ash Borer Beetle. This brought much discussion of the various chemicals used, timing of treatments, how trees are chosen for treatment, and a host of other pertinent uneasiness over the threat of this insect.

There was additional conversation that ranged from questions on the chemicals being used and the effects to the environment; suggestions that treatment was excessive without a beetle in a 15-mile radius; suggestion that a thorough plan be put into place before treating trees with chemicals; unnecessary cost now with an already strict budget. The motion failed with 4-4-1 (MH, SS, BB, LM opposed; JW abstained). The original motion to accept Line Item 84 for \$15,900.00 was accepted with a vote of 5-4-0 (KN, JW, MS, JL opposing).
