# DISCUSSION AND REVIEW OF THE FOLLOWING PROPOSED REVISIONS SUBMITTED BY THE ZONING STUDY SUBCOMMITTEE:

- PURPOSE SECTIONS
- SPECIAL PERMITS
- SITE PLAN APPROVAL
- LANDSCAPING, SCREENING AND BUFFERS

Mr. Creamer stated that there is a lot of work to be discussed with the zoning amendments brought forth by the ZSSC. This meeting is dedicated to a work session on the Purpose Sections of 5.01, 6.01 and 7.01.

Board members had a lot of discussion and posed many questions. They realize Ms. Bubon is working on a cluster bylaw for Rural Residential, which may answer some of their concerns.

### 5.01 PURPOSE:

- Change the word cluster to flexible development
- Delete the sentence starting, —" The regulations preserve....."
- Delete, "....by promoting aesthetically pleasing environments"
- Questioning the words "safety" and "energy conservation"
- Delete, "to establish sewer avoidance area" the Board feels sewer issues should be the jurisdiction of the Selectmen and do not want to interfere with other Boards.
- Delete the last sentence, "In addition.......

The Board also questioned the micro-brewery and adult day care as permitted uses when the proposal was only to delete trailer coach park.

#### **6.01 PURPOSE**

The Board felt that there is not a lot of difference between RR and SR. The Board would like a little more explanation on the difference and tabled discussing it until Ms. Bubon can explain.

#### 7.01 PURPOSE

- Delete the last sentence
- Questioning the figure 75, 000 sq. ft. is it necessary to limit the size, and if so, what is the rationale
- Re-visit Commercial Business was viewed as business unfriendly at town meeting
- Not a good idea to keep coming back to Town meeting after something is voted down (specifically regarding CB)

The Board agreed that there are still a lot of questions that need to be answered and will work with the Town Planner and resolve the issues.
