TOWN PLANNER UPDATE

Ms. Bubon met with Dr. Gill and T. Chamberland, Tree Warden, regarding some landscape issues. Dr. Gill will work with T. Chamberland and resolve all outstanding issues.

The clothing bins on Brookfield Road will be removed.

PUBLIC HEARING FOR RICHARD LEO FOR SITE PLAN APPROVAL TO ALLOW THE CONSTRUCTION OF A PARKING LOT AND BUILDING ADDITION WITH ASSOCIATED SITE WORK AND TO CHANGE THE USE FROM A SINGLE FAMILY RESIDENCE TO A BEAUTY SALON AND ACCESSORY APARTMENT.

Ms. Quigley read the legal notice.

Mr. Jalbert of Jalbert Engineering spoke on behalf of the applicant. The applicant requests a Site Plan Approval to construct a parking lot and building addition and to operate a salon in the downstairs with the owner's residence being upstairs at 13 Main Street. Since the lot and structure do not conform to current zoning requirements, the applicant needed a Special Permit from the Zoning Board of Appeals to move forward with this project. The applicant also requested a variance to allow the handicap parking space in the front yard setback. These approvals were granted on September 5, 2007. Additionally, the applicant has applied for and received an Order of Conditions from the Conservation Commission for the proposed project.

Board members questioned the following:

Height of the wall in back corner – light mounted on that wall Number of parking spaces Staggering appointments Landscaping

Mr. Jalbert answered all the concerns. The applicant is requesting a waiver pursuant to article/section 25.06 (j) of the Sturbridge Zoning Bylaws, as amended 2007, which requires that "A Landscape Plan Prepared by a Certified Landscape Architect, Horticulturist, or Arborist Shall be Submitted with each Site Plan applications, unless an exception is granted by the Planning Board."

All landscaping shall be installed as per the plans submitted and as per the notation on the plan. Sheet 8 of 8 shall be revised to include the notation that a vine will be planted along the base of the wall to provide a more aesthetically pleasing look. Additionally, the Tree Warden shall be contacted for inspection once the plantings have been installed.
