Mr. Loin of Bertin Engineering spoke on behalf of the applicant.

Mr. Loin stated that he met with Mr. Morse, DPW Director, and addressed all his concerns which are:

- Stormwater management has been provided for the northerly parking lot Snow storage swales improved
- Metal beam guardrail has been provided for all three pavement extensions
- Lighting has been provided for the northerly parking area (building mounted lights)
- Traffic delineations (arrows, signs) for all entry/exit points have been provided
- The southerly detention basin outlet has been adjusted creating an improved headwall pipe connection and easier field installation
- 1.5 -1 slopes have been provided for structural embankment

The Board had the following concerns:

- Lack of lighting in the back corner of the building Mr. Loin stated that he would add another light
- Drainage in the front flowing to the next property Mr. Loin stated that the detention basin is larger and would slow down the flow eliminating the problem
- Easement agreement Mr. Loin stated that it is shown on the plans
- Mr. Morse is recommending that no construction take place until the design of the field be checked by the DPW personnel for accuracy since basin elevations may need to be adjusted depending upon the actual water table elevation this will be added to the conditions for approval # 13
- Changes in the front setback will it increase the visibility of the building and parking lot from Route 20 Mr. Loin stated that the changes would screen the lot and building more than it is screened now and the visibility will not increase
- Compact car parking Mr. Loin stated not a good option at this time

- The BOS has directed the Town Administrator to work jointly with the Planning Board/Town Planner in facilitating discussions and relationship building with MassDOT relative to jointly undertaken project improvements in the CT District.
- The Planning Board has agreed to provide periodic reports to the BOS relative to discussions, needs and or challenges for which the Board may be able to provide assistance/support/guidance.
- The Planning Board has agreed to identify priorities (near-term and long-term) for improvements in the CT District that can then be reviewed/discussed/adopted by the BOS as part of an overall policy
